This course will explore recent developments in Texas insurance law including: Additional Insured coverage, Professional Services exclusions, requirements to trigger a Covered Pollution Event, recent cases addressing policy construction and interpretation rules, and attorney client privilege issues. Attendees will gain insight into recent court decisions affecting insurance coverage and coverage pitfalls to avoid, in addition to insight into negotiating with underwriters during policy placement or renewal discussions.
